## Introduction



Over the last few years, Market Surveillance Authorities (MSAs) and civil society across Europe have increasingly joined efforts to generate energy savings by preventing losses resulting from non-compliant products. Their work raises confidence among purchasers, manufacturers, and retailers, whilst improving the enforcement and impact of EU energy efficiency legislation. 
# Market Surveillance: More Capacity and Clarity - More Impact

## PROSAFE H2020 Projects

EEPLIANT2014, EEPLIANT2016, and MSTyr15 Joint Actions help deliver the intended economic and environment benefits of the EU Energy Labelling and Ecodesign Directives by increasing the rates of compliance with the energy efficiency requirements.

The three EU-funded projects, have built a pan-European community to support EU's energy efficiency goals. 28 Market Surveillance Authorities have been cooperating to coordinate their monitoring, verification, and enforcement actions and achieve transnational impacts across the EU Single Market.

The three project consortia carried out coordinated market surveillance and tested energy performance across different product sectors: LED lamps, heaters, printers, household and professional refrigerating appliances, network standby products, and tyres. The EEPLIANT programme is set to continue with an EEPLIANT3 project starting in June 2019 with authorities from 20 EU Member States and Turkey.



## INTAS

With the INTAS - Industrial and tertiary product Testing and Application of Standards project, ECOS was working with 11 national market surveillance activities and partners to support market surveillance of Ecodesign requirements for large industrial products. These products raise new challenges due to their complexity and size.

## ANTICSS

In April 2018, the ANTICSS - Anti-Circumvention of Standards for better market Surveillance project started with the goal to assess if and how Ecodesign and Energy labelling legislations and harmonised standards can be circumvented in order to achieve a better product performance.

## Relevance

Building on the 2020 Climate and Energy Package, the 2030 Climate & Energy Framework sets a target of at least 32.5% improvement in energy efficiency. Achieving this ambitious goal requires, amongst other things, an effective market surveillance system.

## Impacts

The impact of the 28 Ecodesign Regulations and 16 Energy Labels is tremendous: according to the European Commission, 9% of the current total EU energy consumption will be saved yearly from 2020 onwards thanks to the current rules. This is nearly half of the energy savings target set by the EU for 2020. But as for every European policy, verification of compliance are major conditions for the success of the Ecodesign and Energy Labelling policies. The projects help the Member States authorities to cooperate with key stakeholders e.g. industry associations, civil society, policy makers, standards developers, etc., in achieving higher level of awareness and higher rates of overall product compliance with the EU legislation requirements.

## Challenges

Part of the energy efficiency challenge is that some products sold on the market consume more energy than allowed by the legislation and declared by the manufacturers. This session will highlight how a series of pan-European market surveillance projects implement change on the ground to help shape the future of EU's market surveillance on energy efficiency. Defeat devices, circumvention, testing of products, metrics to enable better and more comprehensive assessment of impacts and energy savings are all key topics on our agenda. Lead experts from MSAs, the European Commission, and civil society will share best practices and discuss policy challenges based on the practical work undertaken in the above projects. The audience will be able to interact with the panel by giving their opinion during Q&A sessions.

## Background information

**PROSAFE** is a non-profit professional organisation for market surveillance authorities and officers from throughout the European Economic Area (EEA). Founded in 1991, its primary objective is to improve the safety of users of products and services in Europe. Since 2006, PROSAFE has taken the initiative to coordinate more than 20 EU funded Joint Actions between market surveillance organisations within the EEA.
