# Call for Offers

# for the purchase of video production services under Work Package 1 - Management, Communication and Administration

# 1. Background

PROSAFE is a non-profit NGO established in 1991 by market surveillance officers from various countries throughout Europe. Its main aim is to contribute to the compliance of products and services by promoting best practices in market surveillance. Since 2006, PROSAFE has established itself as the major organising and coordinating body for Joint Market Surveillance Actions in Europe.

PROSAFE's main task is to coordinate Joint Actions between Market Surveillance Authorities. Each Joint Action comprises a number of work packages that target specific product groups, and a number of activities aimed at developing methods and best practices.

In 2019, PROSAFE became the coordinator of the Energy Efficiency Compliant Products 3 - EEPLIANT3<sup>5</sup>. EEPLIANT3 is a pan-European Concerted Action on market surveillance aiming to achieve impacts in line with the objectives of the Horizon 2020 Work Programme 2018-2020 Secure, Clean and Efficient Energy. The project is funded by the European Union (EU) under the Horizon 2020 framework with a duration from June 2019 until November 2023. Two other organisations are supporting PROSAFE in the coordination of the project: the Austrian Energy Agency and the Danish vores bureau.

The objective of this Concerted Action is to help deliver the intended economic and environmental benefits of the framework Regulation for Energy Labelling 2017/1369 and Ecodesign Directive 2009/125 by increasing the rates of product compliance with them. This is achieved through the coordination of the monitoring, verification and enforcement activities and through enhancing the knowledge, skills and experience of Market Surveillance Authorities (MSAs) and other organisations from 21 countries:

Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, France, Germany, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, The Netherlands, Portugal, Slovenia, Spain, Sweden, and Turkey.

The project comprises 12 Work Packages (WP). Product inspection and laboratory testing activities are performed in 7 of the WPs. Specifically:

- WP-6 on New challenges and emerging issues, with testing of a very small number of Wine Storage apptiances, TV Monitors, and Washing machines
- WP-7 on Air conditioners

- WP-8 on Domestic tumble dryers
- WP-9 on Water heaters and hot water storage tanks
- WP-10 on Ventilation units
- WP-11 on Lighting products (LED lamps and LED luminaires with fully integrated non-removable LEDs)
- WP-12 on Local space heaters (portable electric heaters, convector electric heaters (any size), underfloor electric heaters, electric storage heaters, closed gas fires, wood stoves, pellet stoves).

All the WPs apply a risk-based approach that is designed to detect, and then bring non-compliant products into conformity, or in serious cases remove them from the market. Consequently, the results of the EEPLIANT3 inspection and testing activities are not statistically representative of the levels of non-compliance of the EU market.

As part of the communication and outreach activities under Work Package 1 on Management, Communication and Administration, led by PROSAFE, the project is expected to deliver by September 2023 a short three-minute video in line with the minimum requirements set out in Grant Agreement (GA) No. 832558 as explained below in Section 3.

# 2. Subject

The subject of this Call for tenders is the purchase of time-bound audio-visual/video production services for the production and publishing of a short video on the testing activities carried out in the context of EEPLIANT3, in coordination with the Project Coordinator (PROSAFE), the participating MSAs, and the test laboratories concerned, if required.

# 3. Description of requested service

The contractor shall produce one short 3' minute IPR-free clip providing an overview of the project's testing methodologies, outputs, and conclusions in a conceivable way and with a clear pedagogical objective.

The purpose of the video is to describe the overall project, the testing process and to present the main results and conclusions, alongside practical tips for consumers. More specifically, the video should aim to:

- Demystify the testing methods deployed by the EEPLIANT3 product-specific activities.
- Advocate the benefits of EU-wide market surveillance in ecodesign and energy labelling and explain how they compensate for deficiencies in resources, experience, and knowledge amongst European MSAs.
- Leverage over time by producing relevant content that has a long lifespan.

The concept of this short explainer video may involve field filming at selected test laboratory facilities in various locations across the EU, as well as short video interviews with project participants and other key figures involved in the project (including European Commission officials located in Brussels, Belgium).

For the purpose of this Call for tenders and the award process, tenderers should consider a hypothetical scenario of three travels for filming in three EU locations, Brussels being one of them. Travel and field









production requirements and volume will be defined together with the selected service provider prior to the signature of the contract. Accordingly, travel and accommodation costs <u>should not</u> be included in the quoted price (see below Section 7). Such costs will reimbursed in accordance with the relevant effective European Commission rules.

The service includes the pre-production (research, storyboarding, scriptwriting, proof-reading, and shoot planning), studio and/or field filming, and post-production (compose video footage, motion graphics, VFX, editing, sound mixing and revisions, English voiceover and on screen text translation).

The video should be produced in English and include closed captions in the 18 national languages of the participating Market Surveillance Authorities: BG, CZ, DE, DK, GR, HR, FR, IE, IT, LV, LT, MT, NL, PT, SL, SK, SE, TR.

If a tenderer intents to outsource part or parts of the requested service, this must be clearly indicated in the tender, including the name and a description of the proposed subcontractor/external service provider together with an explanation of roles and tasks.

The video should be suitable for dissemination via all popular web media platforms, including YouTube, Twitter and Facebook.

The contractor should be able to deliver a first draft of the video in English by 31 March 2022 and a final version of the video, including captions/subtitles, by 31 May 2023 at the latest. The signature of the service contract is expected in December and the commencement of the pre-production work is expected to start in January 2023.

#### Audience targeting/segmentation:

#### Primary:

- a) Active population in the 21 participating countries, as indicated in Section 1, with low awareness on energy efficiency/energy consumption and the benefits of the EU ecodesign and energy labelling policies, including market surveillance;
- D) Policy makers and legislators at EU and national level;
- c) Relevant industry stakeholders/economic operators (e.g. manufacturers, importers, installers, etc.) within the meaning of Article 3 of Regulation (EU) 2019/1020

#### Secondary:

d) EU/EEA MSAs.

## 4. Exclusion criteria

Tenderers found to be in any of the following exclusion conditions will be rejected and excluded from the evaluation procedure:

a) they are bankrupt or being wound up, are having their affairs administered by the courts, have entered into an arrangement with creditors, have suspended business activities, are the subject e

proceedings concerning those matters, or are in any analogous situation arising from a similar procedure provided for in national legislation or regulations;

- b) they have been convicted of an offence concerning their professional conduct by a judgment which has the force of res judicata:
- c) they have been guilty of grave professional misconduct;
- d) they have not fulfilled obligations relating to the payment of social security contributions or the payment of taxes in accordance with the legal provisions of the country in which they are established or with those of the country of the contracting authority or those of the country where the contract 's to be performed;
- e) they have been the subject of a judgment which has the force of res judicata for fraud, corruption, involvement in a criminal organisation or any other illegal activity detrimental to the European union's financial interests;
- f) following another procurement procedure or grant award procedure financed by the Community budget, they have been declared to be in serious breach of contract for failure to comply with their contractual obligations.

Tenderers are asked to provide a Declaration on Honour (see Appendix A) stating that they are not in one of the situations giving rise to exclusion from the procedure, as listed above. You must use the model circulated with the tender documentation, reproducing it word for word and in its entirety.

#### Acceptance of the standard terms and conditions for PROSAFE contracts

The submission of an offer under this Call for tenders implies that tenderers:

- Accept PROSAFE's "General Conditions for Tender" as attached to this specification (Appendix B).
- Accept that CINEA (EU Agency managing the Horizon 2020 programme), the European Commission, the European Court of Auditors, and OLAF (European Anti-Fraud Office) have the right to carry out checks, reviews and audits on contractors and subcontractors during or after the implementation of the EEPLIANT3 Concerted Action.

## 5. Selection criteria

Tenderers must demonstrate compliance with the following minimum technical and professional capacity criteria:

1) Proven technical capacity and experience in audio-visual production with <u>at least</u> 5 audio-visual projects in the last 5 years prior to this Call for tender, of which at least 3 including field production and 2 motion graphics, commissioned by the European Commission or its Agencies or other external international clients.

[NOTE: In case a single video includes live-action and animations/motion graphics (i.e., mixed/blended type), its reference can be used to fulfil the requirements for both video classes, i.e. field production and motion graphic video]

Evidence: Project portfolio with a detailed list of videos and video references, including the name of the client, value (if not confidential), implementation timeline, web link to the video, a detailed









description of scope, concept and tasks carried out by the tenderer, main technical specifications (e.g. video format, frame rate, resolution, language, etc.) for each listed video.

- 2) Proven professional capacity, with a team including, as a minimum, the following profiles:
  - a) Creative/Art Director: Master's degree in a relevant field and at least 4 years of relevant professional experience OR a Bachelor's degree in a relevant field accompanied with post-graduate professional experience of minimum 5 years. Proficiency in English (oral and writing) at least C1 level.
    - **Evidence:** CV detailing education and professional qualifications, relevant experience, list of projects, knowledge of software relevant to the role, level of English language proficiency.
  - b) Video Production Assistant: Bachelor's degree in a relevant field and at least 2 years of relevant professional experience. Proficiency in English (oral and writing) at least C1 level.
    Evidence: CV detailing education and professional qualifications, relevant experience, list of projects, knowledge of software relevant to the role, level of English language proficiency.
  - c) Video Editor: Master's degree in a relevant field and at least 4 years of relevant professional experience OR a Bachelor's degree in a relevant field accompanied with post-graduate professional experience of minimum 5 years. Proficiency in English (oral and writing) at least C1 level.
    - **Evidence:** CV detailing education and professional qualifications, relevant experience, list of projects, knowledge of software relevant to the role, level of English language proficiency.
  - d) Copywriter: Master's degree in a relevant field and at least 4 years of relevant professional experience OR a Bachelor's degree in a relevant field accompanied with post-graduate professional experience of minimum 5 years. Proficiency in English (oral and writing) at least C1 level.
    - **Evidence:** CV detailing education and professional qualifications, relevant experience, list of projects, knowledge of software relevant to the role, level of English language proficiency.

Tenderers must ensure that all proposed profiles shall remain the same during the execution of the service contract for delivery of the service.

#### 6. Award criteria

Tenders complying with the minimum selection criteria will get scored and then also evaluated according to the following technical award criteria with a view to select the offer that provides the best value-formoney / price-quality ratio.

#### Technical Award Criterion 1: Proposed video concept

- a) Quality of the proposed video concept and the proposed storyline according to the description of the requested services in Section 3 above.
- A detailed project time plan for the delivery of the service with a breakdown of all the necessary tasks and a description of work.

Technical Award Criterion 2: Quality control system









- Assessment of the quality control system to be applied for the delivery of the requested service, including the management and mitigation of production risks and language quality
- b) Delivery time guarantees
- c) Continuity of the service guarantees in case of absence of a team member

## 7. Financial Offer

Tenders will be assessed according to the best value-for-money/price-quality ratio award method.

Tenderers are requested to submit their financial offer for the delivery the requested services as described in Section 3 above. The total amount of the offer should include <u>all charges/expenses</u> except for travel and accommodation costs which will be reimbursed in accordance with the relevant applicable European Commission rules as well as costs for the transport of equipment for filming purposes that will also be reimbursable expenses.

Quotations should also include costs for post-production modifications in the video, in case this will be required by the client.

The quoted price must also include any potential costs for renting A/V or other equipment and/or the outsourcing of tasks necessary for the delivery of the requested service under this Call for tenders.

In the case that a tenderer will use or purchase any external services for delivering part or parts of the requested service, this must be clearly indicated in the offer together with an explanation of roles and tasks.

The quoted price should be expressed in Euros, with zero-rated VAT.

PROSAFE is VAT registered as taxable person established in Belgium with VAT number BE 0809.226.854 (Belgian Chamber of Commerce 809 226 854). All invoices shall mention the BE VAT number and be issued with zero VAT, making reference to the reverse charge mechanism according to Articles 44 and 196 of the VAT Directive 112/2006.

Terms of offer must be valid for acceptance (or negotiation) for at least 3 months from submission. PROSAFE reserves the right to negotiate with one or more shortlisted tenderers before taking a decision on the placing of a contract. The offer shall remain valid until changes are agreed in writing.

invoicing will be discussed and agreed before the placing of the contract.

#### 8. Tender documentation

To be considered complete and go through the evaluation process, tenders should include:

- A signed Declaration on Honour, as per Section 4 above, sent in original with blue ink hand-written signature by post (Appendix A) and in digital scanned copy via email.
- Complete tender documentation/evidence fulfilling the selection criteria as described in Section 5
  above.







- Complete technical offer addressing the two award criteria and sub-criteria as described in Section 6 above.
- A financial offer as per Section 7 of this Tender Specification.

# 9. Questions about the tender specifications

Verbally addressed questions will not be answered in fairness to all bidders.

# 10. Tender evaluation and contracting timeline

- 1. Tender published on EEPLIANT3 and PROSAFE websites on 4 November 2023. All interested bidders that registered with PROSAFE beforehand will be notified directly by email at the same time.
- 2. Deadline for submission of questions about the specification: 24 November 2022, 17:00 CEST.
- 3. Deadline for submission of tenders: 05 December 2022, 17:00 CEST.

Tenders must be sent to the offices of PROSAFE in hardcopy (Avenue des Arts/Kunstlaan 41, 2nd floor, 1040 Brussels, Belgium) and via email to <a href="mailto:joana@rprosafe.org">joana@rprosafe.org</a> and <a href="mailto:joana@rprosafe.org">joana@rprosafe.org</a> with the subject header 'EEPLIANT3 WP1 Video Production Tender'. Hardcopies must be received at latest by 12 December 2022 - stamp date being the proof that they were sent no later than 05 December 2022.

Tenders received after the deadline will be rejected.

- 4. PROSAFE aims to notify all bidders that succeeded or failed by 15 December 2022. They will be granted 5 working days to request clarifications or appeal the decision by email.
- 5. PROSAFE will analyse the appeal and provide a final decision.
- 6. Clarification of bid details and implementation specifications with the preferred bidder will take place in early January 2023.
- Contracts are expected to be signed by end of December 2022.
- 3. Work is expected to commence in January 2023.

This timeline is indicative and remains subject to changes depending on the circumstances and developments within the project.







## 11. Assessment of tenders

The selection process will be as follows:

- 1. Screening of tenders for compliance with the exclusion criteria. Non-compliant tenders are rejected.
- 2. Assessment of qualifying bids based on the selection criteria.
- 3. Assessment of the qualifying bids on the award criteria, leading to selection of the preferred bidder.
- 4. Bidders are informed on the results of the tender evaluation.
- 5. Preferred bidder contacted to arrange a pre-contractual interview to discuss the production plan and specific requirements.
- 6. Decision on final specifications and contracting.

The goal of the evaluation is to understand the ability of candidates to deliver the requested service in a timely manner and to a high quality standard, and to assess the bidder's professional and technical capacity, competence and experience of similar work, as a whole and for the proposed individuals.

In order to select the offer that demonstrates the best value for money, the assessment of the qualified tenders will be done as follows.

Each criterion will be awarded a score from 0 (= not satisfactory) up to a maximum number of points as indicated below, based on the level of detail provided, the relevance to and coverage of the expressed requirements and the quality of the proposal. Tenders that will not reach the minimum threshold for one of the set criteria will not be subject to a further evaluation:

- 1) Technical capacity and experience: Maximum number of points = 5 / Minimum threshold to be subjected to a best price-quality ration assessment = 3.
- 2) Professional capacity: Maximum number of points = 5 / Minimum threshold to be subjected to a best price-quality ration assessment = 3.
- 3) Quality of the proposed video concept and storyline: Maximum number of points = 12 / Minimum threshold to be subjected to a best price-quality ration assessment = 7.
  - a) Design and quality of the proposed video concept Maximum 8 points / Minimum 4 points
  - b) A detailed project time plan for the delivery of the service with a breakdown of all the necessary tasks and a description of work Maximum 4 points / Minimum 2 points
- 4) Quality control system: Maximum number of points = 8 / Minimum threshold to be subjected to a best price-quality ration assessment = 4.
  - a) Assessment of the quality control system to be applied for the delivery of the requested service, including the management and mitigation of production risks and language quality -Maximum 4 points / Minimum 2 points
  - b) Delivery time guarantees Maximum 2 points / Minimum 1 point
  - c) Continuity of the service guarantees in case of absence of a team member Maximum 2 points / Minimum 1 point







The total score achieved for the above four criteria will carry a weight of 70% relative to the final score. The total maximum number of points is 30.

5) Financial offer.

The score for the financial aspect of the bid will carry a weight of 30% relative to the final score.

The tenderer which will achieve the highest total score and meets all the requirements set out in this Tender Specifications will be invited to a pre-contractual interview with the EEPLIANT3 project team.

The tenderer may be invited to provide additional information to clarify the already presented services or where a clerical error occurred provided that the principles of transparency and equal and fair competition are respected.

## 12. Standard terms and conditions for the contract

Please see the attached standard terms and conditions that will apply to the contract (Appendix A).

The submission of an offer under this Call for tenders implies that tenderer accepts PROSAFE's "General Conditions for Tender" as attached to this tender specification.

## 13. Data protection

Tenderers must ensure compliance with the applicable data protection rules at national and EU level including Regulation (EU) 2016/679 (General Data Protection Regulation) on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation)<sup>3</sup>.

## 14. Further information
